

WHY MAKE A WILL?

By making a Will, you can control what happens to your property and your assets after you die. If you don't have a Will, the law will determine how your assets are distributed, regardless of what your wishes might have been. Relatives, charities or friends you might otherwise have chosen to give something to may miss out.

If you are not married to or in a civil partnership with your partner, it is particularly important that you make a Will, as the law does not automatically give your partner the same right to inherit as a spouse or civil partner. Without a Will, your partner may be left with nothing.

If you have children or other dependants, we would recommend that you make a Will to ensure that they are provided for in the way that you would wish. A Will can also help to protect your Estate from a large Inheritance Tax bill, so there will be more to pass on to your loved ones.

DO I NEED A SOLICITOR?

It is possible to draw up your own Will, but it is not advisable. There are strict formalities that need to be followed in order for a Will to be valid, and a solicitor can make sure that these are complied with. The more complicated your circumstances, the more complicated your Will may need to be to reflect this, and the more important it is to get proper legal advice from a firm you trust.

The last thing you would want is for mistakes to be made in your Will that might lead to problems for your family and friends after your death.

Homemade Wills are also more at risk of being challenged – having your Will drawn up by a solicitor means that someone independent has ensured that the Will is drafted correctly, and that there has been no undue influence placed on you. KEEPING YOUR WILL UP TO DATE

You should review your Will every 5 years, or after any major life change – such as getting married or divorced, entering into or dissolving a civil partnership, having a child, or moving house. It is best to deal with a major change by having a new Will drawn up; if a change is less significant it is possible to make minor alterations to your existing Will with a separate document (called 'a Codicil').
