

POWERS OF ATTORNEY

A Power of Attorney enables someone chosen by you to deal with your affairs in circumstances where you are not able to.

You might need a Power of Attorney because you are going to be out of the country for an extended period of time and documents may need to be signed during your absence. Alternatively, you may choose to have a Power of Attorney in place in case you are not able to make decisions about your affairs because of long-term illness or loss of mental capacity.

Different types of Powers of Attorney can be used in different circumstances:

- General Power of Attorney. This is useful for situations where you are not able to sign documents or deal with matters yourself. However, you must still have mental capacity. A General Power of Attorney cannot be used if you have already lost, or subsequently lose, mental capacity – either temporarily or permanently.
- Lasting Power of Attorney: Property and Affairs. This power will enable your attorneys to deal with your finances and your property.

If you have one in place and have registered it with the Office of the Public Guardian, it can still be used even if you later lose your mental capacity.

 Lasting Power of Attorney: Health and Welfare. This power will enable your attorneys to make decisions about your personal health and welfare in the event that you lose capacity. It can include giving your attorneys the power to decide whether or not you should receive life sustaining treatment. If registered, it can be used should you later lose your mental capacity.

Giving someone the power to make decisions on your behalf is a big step.
